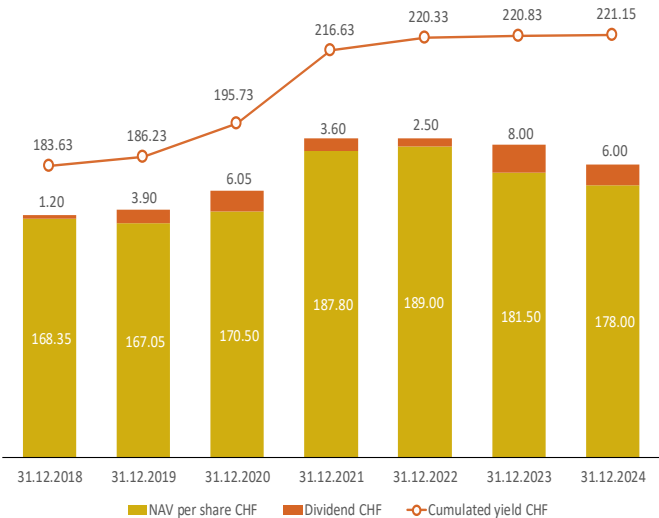

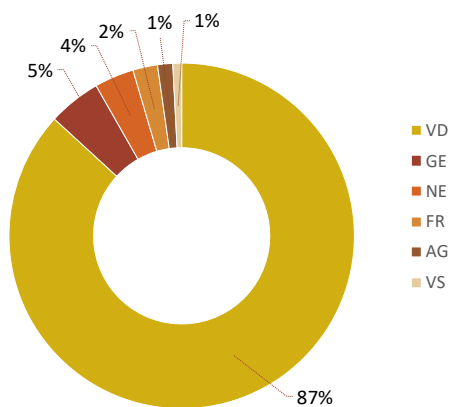

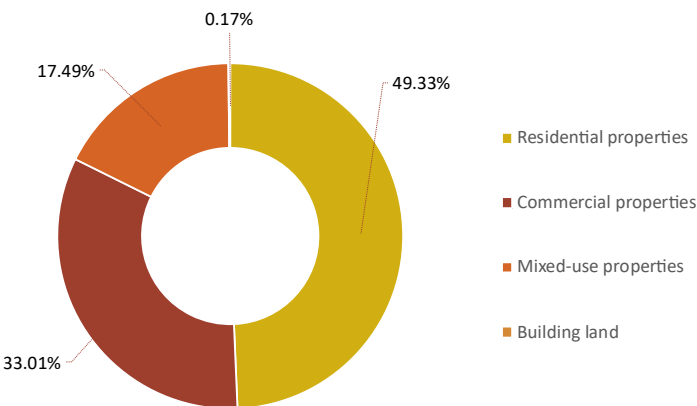

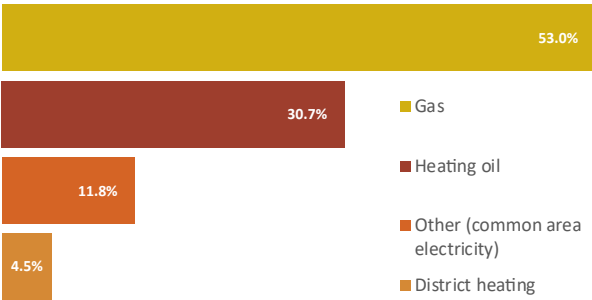
Breakdown by region
